RFP SEARCH FINALIST: DEFERRED COMPENSATION PLAN RECORDKEEPER

T. Rowe Price ("TRP")

Mssers. Metz and Vaira and Mses. DeCamillo and Evans, TRP, were invited to join the meeting following the Board's RFP for Deferred Compensation Plan Recordkeeper. Following review of materials, previously distributed, and answering questions posed by the Members, the TRP representatives thanked the Members for their time and excused themselves from the meeting. Ms. Payne reported that TRP had completed the Board's Vendor Disclosure Policy; there were no conflicts to report, no political contributions made and the firm had made disclosures consistent with Public Act 98-1022.
